- Derived from Latin word"Panis" which means "bread", to eat bread together
- Corporation and Company are sometimes used Interchangeably.
- According to US C.J John Marshall, "A Corporation is an artificial being, invisible, intangible and existing only in the contemplation of law".
- "A company is an association of persons united for a common object".
- "A company is an artificial person created by law, having a separate entity with perpetual succession and a common seal".

# DISTINCTIVE FEATURES OF COMPANIES

#### 1- They are Corporations

- Artificial legal person invested by law with most of the responsibilities of a natural person.
- The Company may own property, enter into contracts, inflict or suffer wrongs, sue and be sued and do many other things that are done by human being.
- However, they cannot vote, marry, become member of the parliaments or even become lawyers.

#### 2- The Liability of its members is Limited

- · The Liability of its members as shareholders is limited up to the shares subscribed by them.
- · The Liability may also be limited up to guarantee in the case of Non-profit organizations. (Sec-42)

#### 3- Perpetual Succession

The existence of a company is continuous, and its life is not affected by:

- Death
- Insolvency
- Or Lunacy of its members

#### 4- Common Seal

A company being an artificial person cannot sign documents.
